No 1. Welcome - Guðmundur R. Jónsson Introduction round of participants Minutes for approval from the Board Meeting, October 2021 - AGREED 2. NUAS website - presentation of a new website Ragna Skinner presented a framework for a new NUAS website where the main idea is to have a more interactive facad. Proposal is that for time being, the new website is located at UI. Group leaders and groups obtain access and test a beta version of the new website. Voted on proposal and approvedto go further. General secretary will follow up with group leaders and board. 3. Presentation of NUAS group activities - seminars in the period '21-'22. Many group are planning future events and conferences According to NUAS minutes from October 2020 it was agreed that the University of the Faroe Islands could have representatives in the groups. Joahn Ísak Suni Hansen points out that participation in groups would benefit the development at the Univrsity of Faroe Islands and can bring in members. Board is pleased with activities of groups during the past year in view of Covid-19 circumstances 4. **NUAS financing Economy in connection with seminars** Presentation on behalf of all NUAS groups - Ína Dögg Eyþórsdóttir and Dan Guttke **PROPOSAL** 1. Discontinue the 200 DKR participation fee per participant for events 2. Add to NUAS guidelines that webinars can be offered for free to NUAS members as long as they do not incur any cost 3. If financial compensation is needed for NUAS a solution is to raise the annual fee by 4. If there is a deficit after a seminar/conference, NUAS will split the deficit 50/50 with the host institution up to a maximum amount of 100.000 NOK 5. We ask the Board to encourage member institution to allow for Group leaders/members to be able to travel to physical meetings each year. 6. General Secretary and Group Leaders work on reviewing the guidelines for financing of activities, writing guidelines for seminars/events and reframe the set up for a "Welcome to NUAS" pack for new members Comments from Board member: Anne-Christine Larsson Ljung I believe that NUAS can raise the fee to get financies in the seminars In regards to item 5 it was agreed that the Chair and Board would remind member institutions of their obligations to NUAS and this will be followed up with a letter of recommendation.
